Disaster Preparedness Toolkit Developed For Agriculture & Livestock Sector

The readiness of the Agriculture, Fisheries and Livestock sectors is critical for the sustainability of our Food Security. It is against this backdrop that the Ministry of Agriculture, Lands, Housing & the Environment through its Communications Unit, along with the input of farmers, and fishers have moved ahead with the development of an emergency preparedness toolkit to assist stakeholders within the sector in their planning efforts toward keeping their pets, livestock's, crops, machineries and equipment safe in the event of a disasters.

The toolkit, which is accessible on the ministry's website www.agricultureantiguabarbuda.com provides resources on how to stay current on your disaster plan, and procedures; examples of how to promote preparedness awareness in your communities and engage other stakeholders in your efforts; as well as resources to educate the community about how to assemble emergency supply kit and make an emergency plan.

The toolkit, entitled "Saving Animals, Securing Our Fishers and Farms From Disaster" also outlines for actions Pre, during and Post a disaster.

In addition, there is a tools section which provides sample preparedness brochures, and press materials you can use to develop and distribute your internal preparedness messaging.

A template of the various media houses with their frequencies and other disaster related agencies are also included.

Preparing our Agriculture, Livestock Sector and Fisheries Sectors for unexpected disasters is a civic virtue.

Final Draft of National Physical Development Plan Due

October 14.

September 1, 2011, St. Johns, Antigua: Critical development and planning related issues which highlight the lack of stringent policies were brought to the forefront as the public consultative process on the National Physical development Plan (NPDP), gets underway.

The final draft of the National Physical development Plan, is expected to be submitted to cabinet on October 14 highlights five key planning goals, to maintain and enhance eco-system integrity, foster economic development and engaging livelihoods, enhance livability, improve accessibility and promote efficient and effective governance.

Wednesdays Night, stakeholders spanning various agencies, the public and officials from the public sector added their voice to the draft Sustainable Island Resource Management Zoning Plan (SIRMZP), during a consultation held at the Multipurpose Cultural centre.

The consultation was among series of advocacy being planned to receive feedback on the draft document, which will serve as a guideline for strategic, national spatial development framework that addresses current flaws, and provides the platform for feasible private and public sector expansion.

Section seven, will examine Land Use and Development Control Policies, relating to Development control administrative structure, planning and development control process and development control guidelines for discrete spatial units. While section eight, deals with the implementation process in these phases the immediate actions, short-term actions and long-term actions. The process is expected to take approximately 20 –years.



Code Of Conduct In the Pipeline For Ministries' Staff

The Ministry of Agriculture, Lands, Housing & the Environment as part of efforts to enhance its human resources capacity and the conditions under which employees function, a zero tolerance approach has been taken to workplace violence, including threats, insubordination, harassment, wanton submission of sick leaves, absenteeism, habitual lateness, physical assault, disruptive behaviors and any other matter that compromises workplace safety or the smooth operations within the ministry.

Moves have been made to nip, what appeared to be a developing trend of senior managers reporting that their lives have been threatened by employees. Concerns of insubordination, harassment, disruptive behaviors, the lack of regards for other person's workstation and property is becoming worrisome. Punitive actions have been taken against several employees in the past for infringement of workplace conduct, in some cases relating to theft and threat the police were called in.

Workplace safety is of utmost importance to this ministry; therefore early intervention helps prevent more serious acts. The Ministry recognizes its duty to furnish each employee in its employment and is mandated by law to recognized hazards that are causing or are likely to cause death or serious physical harm, whether emotionally or physiologically to its employees.

Staff members need to discern an "empty threat" from one that is serious. You are advised to be sensitive of about our safety code, by knowing when a threat should be reported to the police or when to obtain outside help to address these matters.



As part of this thrust, the PTCCB a seminar entitled "Effective Regulatory Management of Pesticides and Toxic Chemicals" was held on 28th September, 2011 Fisheries Complex Conference room Point Wharf.

Dr. Spencer explained that pesticides by their nature, pose some risk to humans, animals or the environment. Therefore, he said it is critical that the pesticide labels are used as a guide for safe and effective usage.

The chairman of the PTCCB reiterated that the label contains pertinent information, and urge all stakeholders to read and understand its' content before any pesticide and chemical is being.

MINISTRY SEEKS PUBLIC PARTICIPATION FOR BUY LOCAL CAMPAIGN

The Ministry of Agriculture, Lands, Housing & the Environment will be conducting a Knowledge Attitude and Perception (KAP) Assessment throughout the month of October, as a guide for the launching of a buy —local campaign.

This proposed buy -local campaign will seek to strengthen the local economy by promoting the country's local produce, services, and locally made products.

Chief among the objectives is the Identification of Consumers' Barriers to Buying Local through the execution of a Knowledge Attitude and Perception (KAP) Assessment. Additional objectives include the shift in consumer behavior, development of a strategy that encourages customers to identify with "being Local."

In this regard, the ministry has developed a questionnaire which will be used for the sole purpose a Knowledge Attitude Perception (KAP) assessment to aid in the determination of barriers to persons buying local product and services.

The KAP assessment is being executed by the Communication Unit within the Ministry of Agriculture, Lands, Housing & the Environment which will form the basis for the launching of a National Buy Local Campaign. A multi-sectoral Steering Committee will be established to plan and implement various phases of the Buy -Local Campaign.

Permanent Secretary Mrs. Sharon Peters said, the ministry is interested in learning about local food consumption and its effects on economic development. "The Ministry is requesting the public's co-operation in creating a detail picture of local resources, the expectations of consumers and understanding the kinds of contributions that local products/services/ commodity make to the community. Our questionnaire focuses on the consumption of local food products and locally made products, and will take the average learner approximately five minutes to complete."
